The Putnam County Council met in Regular Session on September 28, 2021, at the Putnam County Courthouse at 6:30 p.m. Dave Fuhrman opened the meeting with the pledge to the flag.

**2022 BUDGET HEARING**

Dave Fuhrman opened the budget hearing. Dave asked for public comments. No comments. Danny Wallace made a motion to close the public budget hearing. Phil Gick seconded. The motion carried unanimously.

**FLOYD TOWNSHIP FIRE**

Budget reduction request so they may fund next year's budget. Discussion was made. Jay Alcorn made a motion to approve. Stephanie Campbell seconded. The motion carried unanimously.

**2022 COUNTY BUDGET LEVY**

Jacque Clements presented a levy worksheet. The County is \$3000 over levy and has a \$1.2 million operating cash balance in County General. (See worksheet) She stated the Public Safety Fund is spending \$100,000 less each year than what is coming in.

Phil Gick asked Jacque what the window is to establish a CCD Fund and do away with the Cumulative Funds. She stated it would have to be done by April 1<sup>st</sup>. Dave stated they should start thinking about it by December.

Council instructed Jacque and Auditor to finish the budget process.

August 17, 2021- Voting districts discussed. Jay Alcorn made a motion to approve. Phillip Gick seconded. The motion carried unanimously.


August 24, 2021 - Budget Meetings – Phillip Gick made a motion to approve. Danny Wallace seconded. The motion carried unanimously.
